## PROCEDURES FOR ORGANIZATIONS USING BLACK POWDER OR EDGED WEAPONS AT STATE PARKS FACILITIES

### **Adopted 2001**

#### A. POLICY

Firearms, artillery firing, and tactical weapons demonstrations, especially those that involve opposing forces, can create many problems of crowd control and coordination. Weapons accidents are frequently due to the movement and confusion inherent in these activities. These agency procedures are intended to address those problems.

Demonstrations at State Parks facilities that involve the use of black powder or edged weapons must conform to the agency's POLICY ON MILITARY INTERPRETATION (attached) and the procedures outlined in this document. Demonstrations that include opposing forces must also conform to the agency's PROCEDURES FOR THE USE OF OPPOSED-SIDES TACTICAL WEAPONS DEMONSTRATIONS AT NEW YORK STATE HISTORIC SITES AND STATE PARKS. (attached)

### B. PARTICIPANTS

All individuals participating in these demonstrations who personally engage in the use of firearms or artillery must be sixteen (16) years of age or older.

For all encampments and tactical demonstrations, the FACILITY MANAGER may designate one organization commander as DEMONSTRATION COORDINATOR. THE FACILITY MANAGER and DEMONSTRATION COORDINATOR shall plan the activities, establish safety controls, and delineate areas for spectators, demonstrations, camps, and weapons clearing.

### C. BLACK POWDER

All black powder brought onto State Parks facilities must be in the form of prepared cartridges, priming tubes or powder horns for firearms, and/or artillery priming. No bulk powder will be permitted. Musket cartridges shall be of paper, rolled in the appropriate 18th- or 19th-century manner, secured in a period manner. Foil, staples, coin wrappers, or plastic tubes are not permissible. Artillery cartridges shall be of three layers of aluminum foil, made on a former corresponding to the bore of the gun. The loads described in the attached table are the maximum loads, and shall not be exceeded.

It shall be the responsibility of each organization to insure that all cartridges, priming tubes, and other explosives are maintained in a secure area or areas designated by the FACILITY MANAGER during the time the organization is on State Parks property. No cartridges or other explosives shall be accessible to the public.

The FACILITY MANAGER and DEMONSTRATION COORDINATOR shall insure that no explosives are unsupervised.

#### D. FIREARMS

It shall be the responsibility of each organization commander to insure that the members of his organization are properly trained in the safe handling, loading, and firing steps for the weapons being used.

It shall be the responsibility of each organization commander to insure that firearms and artillery are inspected for safe condition prior to the demonstration. The FACILITY MANAGER can supply suggested checklists if so desired.

It shall be the responsibility of each unit member to insure that firearms are secured during the time they are on State Parks property.

**No** firearm shall be pointed toward another person, and no weapon shall be discharged toward or over people except as outlined in the section on TACTICAL WEAPONS DEMONSTRATIONS (see Section G, below).

**No** person other than State Parks staff and members of organizations approved to participate in special events on State Parks property shall be permitted to discharge firearms during such events.

**No** member of the public shall be permitted to handle a firearm until a member of the organization has inspected the weapon to insure it is not loaded. This inspection shall include visual checks of priming pan or percussion cone, and use of the ramrod to verify an empty bore.

**No** demonstration of "rapid fire" or speed loading shall be attempted by any member of any organization participating in the special event. This is an unnecessary hazard that will not be tolerated.

Flintlock firearms shall be equipped with a hammerstall (frizzen cover) of leather, and tight, well-fitting, metal flashguards.

### E. EDGED WEAPONS

All replica knives, axes, tomahawks, polearms, swords, and bayonets used for passive demonstration shall have dulled edges and blunted points.

Knives, axes, and other cutting tools used for active demonstration, such as chopping or cutting, shall have sturdy sheaths or scabbards in place whenever the tool is not is use.

Throwing of tomahawks, axes, or knives is not permitted.

The public shall not be permitted to handle any edged weapon.

### F. ARTILLERY

Only commercially reproduced, muzzle-loading artillery pieces shall be used for demonstrations at State Parks sites. These reproductions shall be constructed of cast iron or bronze, with a seamless steel sleeve in accordance with Brigade of the American Revolution standards for all iron guns.

Ideally, an artillery piece should be fired only once during any demonstration. If it will be fired more than once, black powder in any form should not be introduced into the barrel for at least ten (10) minutes after the previous charge has been fired. This is based upon instrumented testing of barrel temperatures taken during firings. Artillery used in tactical weapons demonstrations shall be governed by the regulations outlined under TACTICAL WEAPONS DEMONSTRATIONS (see Section G).

Priming tubes, cartridges and linstocks, or friction primers are the preferred means of ignition for artillery. If a priming horn must be used, it shall contain only enough powder for the immediate demonstration and a possible misfire.

Artillery shall be inspected by the organization prior to each demonstration or ceremony to insure its safe condition for firing.

### G. TACTICAL WEAPONS DEMONSTRATIONS

If so designated by the FACILITY MANAGER, the DEMONSTRATION COORDINATOR shall be responsible for insuring that all organization commanders are adequately briefed on the procedures, locations, and conduct of the event.

No artillery piece shall be moved in a loaded condition.

If an artillery piece is a 6 Pdr or smaller, it may be fired as often as once every five (5) minutes. This interval is allowable IF the interval is measured by watch or stopwatch.

If the piece is to be fired more than once, the gun shall be double-wormed and double-sponged. Cartridges must be rammed only with enough force to seat them, and the powder charge may not exceed 4 ounces of cannon or Fg grade black powder. This is to insure safety, since most artillery accidents occur during the second or subsequent shots.

Troop firings shall be in a direction parallel to and/or away from spectators.

No ramrods may be drawn or used during these events.

Pistols may be carried when appropriate, but shall not be loaded or fired during the demonstration.

Hand-to-hand combat is prohibited at all times.

Bayonets will not be fixed except upon order or approval of the FACILITY MANAGER or DEMONSTRATION COORDINATOR. Bayonets must be unfixed and sheathed prior to units advancing toward each other.

Unit commanders shall verify that all weapons are cleared prior to the unit leaving the field following the demonstration. Any misfires shall be cleared in a safe area designated by the FACILITY MANAGER.

Following each demonstration, or at the end of the event, as determined by the FACILITY MANAGER and DEMONSTRATION COORDINATOR, each unit shall be responsible for inspecting the area and removing all debris, cartridges, paper, or foil fragments.

The FACILITY MANAGER and/or DEMONSTRATION COORDINATOR may remove any organization or individual participant from the event if safety guidelines are violated or if general conduct warrants.

#### H. VISITOR SAFETY AND EMERGENCIES


VISITORS MUST BE KEPT AT THE SAFE DISTANCES SHOWN IN THE RANGE CHARTS (attached) WHENEVER WEAPONS ARE FIRED. Minimum distances for visitors behind demonstration weapons shall be five (5) yards for firearms and twelve (12) yards for artillery. Temporary barriers should be used as necessary.

A staff member, or member of a participating organization who is not involved in the program, should be present to monitor the demonstration to insure the range is clear, visitors understand and observe safety limits, and that, in case of misfires or accident, visitors are kept under control until the situation is resolved. If an observer is not available, it is the responsibility of the FACILITY MANAGER and the DEMONSTRATION COORDINATOR to insure that all safety measures are observed before any weapon is discharged.

Every effort should be made to have emergency personnel standing by on site during the event. Facility staff should be aware of procedures to follow in case of an emergency and participating organizations should be briefed on emergency procedures before the event.



### I PURPOSE

The purpose of these guidelines is to establish standards and guidelines for presenting opposed-sides tactical weapons demonstrations for interpretive use at New York State Historic Sites and State Parks.

#### II DEFINITIONS

Opposed-sides tactical weapons demonstrations (TWD) are programs in which volunteers and staff, organized into accurately equipped recreations of historical military units, engage in representations of appropriate tactical formations, maneuvers, and fire. For the purposes of promotion and public information, TWDs may be described as battle tactics, simulations, or demonstrations.

State Historic Sites and State Parks are those facilities officially designated as such under the jurisdiction of the New York State Office of Parks, Recreation and Historic Preservation or its licensees.

Staff are members of the permanent or seasonal staff at State Historic Sites and State Parks.

Volunteers are members of re-created military organizations who participate in interpretive programs, including TWDs, at State Historic Sites and State Parks.

### III RATIONALE AND CONDITIONS

It is acknowledged that TWDs have relevance, under certain circumstances, to interpretive programming at New York Historic Sites and State Parks. In order to determine whether such programs are appropriate and advisable at individual facilities, certain conditions must be met:

- 1. The proposed TWD must be relevant to the military history and interpretive themes of the facility.
- 2. The TWD must be planned and presented as an interpretive activity with appropriate, accurate, and comprehensive information provided to visitors. This information may be presented verbally, or in printed form.
- **3.** The facility must insure adequate personnel, space, and services to safely conduct the proposed TWD and to accommodate the anticipated visitor audience.
- **4.** The TWD must be conducted in accordance with the PROCEDURES FOR ORGANIZATIONS USING BLACK POWDER OR EDGED WEAPONS AT STATE PARKS FACILITIES.
- TWD participants must be members of an organized reenactment or military unit with an identified officer/non-commissioned officer or group leader. All participants must be pre-registered as specified by the facility.
- **6.** The FACILITY MANAGER must retain complete authority in matters of program planning, supervision, and implementation, including the ability to limit or terminate a TWD in the event of a rule violation or perceived hazard.

### IV PLANNING

Planning for TWDs must be done in advance as part of the overall planning for an interpretive event. Planning should involve facility staff and representatives of the participating group(s). The plan should include:

- **1.** A detailed event program (i.e. agenda of timetable of activities).
- **2.** An outline for conducting the TWD.
- **3.** Personnel assignments.
- **4.** A list of required supplies, equipment, and facility needs.

### V INTERPRETATION

It is important that the maneuvering and firing of simulated military forces is comprehensible to the public. Therefore, a number of interpretive considerations must be addressed:

- **1.** The TWD must be outlined or scripted.
- **2.** The TWD must be explained by a narrator and/or a visitor handout.
- 3. The simulation of casualties may be permitted to more accurately interpret the period of muzzle-loading weapons and the resultant strategy, tactics, and consequences. The simulation of casualties is to be accomplished by a "silent fall" whereby the participant falls silently to the ground and remains motionless and still until the demonstration is completed. If casualties are simulated, the narrator must explain and interpret them within the context of the demonstration.
- 4. The narration/text must explain the visible motions as well as address related matters such as the influence of weapons technology upon tactics, the extent and impact of casualties, the goals of military commanders in using such tactics, and related factors.

### VI SUPERVISION AND CONTROL

Proper supervision is essential to the success of a TWD.

- 1. Ultimate supervision of a TWD, its safety and content, rests with the FACILITY MANAGER.
- 2. A minimum of two (2) individuals designated by the FACILITY MANAGER shall be present throughout the course of the TWD to monitor the conduct of the event.
- **3.** A TACTICAL COMMANDER will be designated for each side of the demonstration from among experienced officers of the volunteer groups. When working with federations of groups, it is best if the federation designates these positions. When working with individual, invited units, the FACILITY MANAGER will designate the opposing tactical commanders.
- A SAFETY OFFICER will be appointed for each side. These positions may be filled by facility staff familiar with the use of black powder weapons or by volunteer participants designated by the FACILITY MANAGER. The official SAFETY OFFICERS of a federation of volunteer groups are also acceptable for this function. All SAFETY OFFICERS must be familiar with the PROCEDURES FOR ORGANIZATIONS USING BLACK POWDER AND EDGED WEAPONS AT STATE PARKS FACILITIES and conform to and enforce them.
- **5.** Facility staff, tactical commanders, individual artillery piece commanders, SAFETY OFFICERS, and any other related personnel will meet on at least one occasion prior to the TWD to discuss the event, inspect the area to be used and review safety procedures, crowd control measures, and the outline for the TWD.

### VII SAFETY

The safety of visitors and participants is the responsibility of facility staff. All safety planning will be based upon the PROCEDURES FOR ORGANIZATIONS USING BLACK POWDER AND EDGED WEAPONS AT SATE PARKS FACILITIES.

### **OF VISITORS:**

- 1. Viewing areas for visitors will be placed at a safe distance (five-yard minimum) from the nearest point of the TWD and oriented so that the action of the demonstration runs parallel to the front of the audience.
- **2.** Crowd control lines or other physical barriers will separate the audience from the TWD participants.

- 3. Crowd control personnel, consisting of facility staff or facility staff augmented by volunteer assistants, will patrol the crowd control lines with one person placed at intervals of approximately twenty (20) yards. They will have the authority to remove spectators form unsafe locations.
- 4. TWD narrators, through the use of public address equipment, will remind spectators of the potential hazards of the demonstration, including anticipated noise levels, and inform them of the necessity of observing restricted areas, safety lines, and the instructions of crowd control personnel.
- **5.** Following the conclusion of the TWD, crowd control personnel will exclude visitors from the demonstration area until the grounds have been policed to remove dropped cartridges, cartridge debris, and other potential safety hazards.

#### **OF PARTICIPANTS:**

- 1. All TWDs will be regulated by the PROCEDURES FOR ORGANIZATIONS USING BLACK POWDER. This includes the distances at which firing is allowed.
- 2. All TWD participants will have their firearms, cartridge boxes, and other weapons inspected by SAFETY OFFICERS immediately prior to the commencement of each TWD to ensure that safety standards are properly observed. SAFETY OFFICERS will have the authority to remove participants found with non-conforming weapons or ammunition.
- **3.** Firearms will be elevated above the heads of opposing TWD participants before they are discharged. In special cases involving demonstrations in fortifications where participants are located at unequal heights, the weapons of the side situated at the lower level may be depressed below the position of the opposing side.
- **4.** With the exception of special ceremonies of other circumstances, no fixed bayonets of unsheathed edged weapons shall be permitted during TWDs.



# POLICY ON MILITARY INTERPRETATION

The New York State Office of Parks, Recreation and Historic Preservation interprets the significant events of New York's military past at its historic sites through archeological remains, exhibits, furnished historic properties, informational signs, publications, and staff. For the further enjoyment of the public, State Parks encourages the active interpretation of historic military life and events through encampments and narrated demonstrations of maneuvers and weapons. All such programs are governed by State Parks' "Black Powder Guidelines," "Procedures for the Use of Opposed–Sides Tactical Weapons Demonstrations," and regional activity permits.
